TAKE NOTICE: Lanark County, the Approval Authority for Draft Plan of Subdivisions, has received an application from 13126102 Canada Inc., County File No. 09-T-25002, proposing the subdivision of land described as Part of the Southwest Half Lot 18, Concession 3, Township of Beckwith, County of Lanark.



PROPOSAL: The subject property is approximately 33.5 ha (82.7 acres) with 274.61 metres of frontage and is currently vacant. The proposed subdivision includes forty-one (41) single detached residential units, two (2) blocks for unevaluated wetlands, one (1) block for a trail connection, and one (1) internal street with a turning circle.

CONSULTATION: Pursuant to Section 51 (19.4) and 51(23) of the *Planning Act*, the approval authority shall give notice to the public and the prescribed parties and may confer with the persons or public bodies that may have an interest in the application. - 2. If a person or public body would otherwise have the ability to appeal the decision of Lanark County but does not make oral submissions at a public meeting, if one is held at the area municipality, or make written submissions to Lanark County in respect of the proposed plan of subdivision before the approval authority gives or refuses to give approval to the draft plan of subdivision, the person or public body is not entitled to appeal the decision to the Ontario Land Tribunal.
- 3. If a person or public body does not make oral submissions at a public meeting, if one is held, or make written submissions to Lanark County in respect of the proposed plan of subdivision before the approval authority gives or refuses to give approval to the draft plan of subdivision, the person or public body may not be added as a party to the hearing of any appeal before the Ontario Land Tribunal, in the opinion of the Tribunal, there are reasonable grounds to do so.
